No clip frames or sawtooth hangers. All work exhibited must be for sale and will be subject to a 25% commission for TCAN members and 30% for non-members; sales tax will be collected. The submission fee is \$10 for the first piece and \$5 for each additional piece—**three entries maximum**. Checks should be made payable to The Center for Arts in Natick.

Along with his commercial work, Traub has exhibited widely and his work is in numerous public and private collections, including the Museum of Fine Arts in Boston, the Cleveland Museum of Art, the George Eastman House, AT &T, the Progressive Corporation and the Centre Pompidou in Paris. Traub has been the recipient of a Massachusetts Council on the Arts photography fellowship. He teaches private classes to individuals and groups on darkroom technique, aesthetic issues and phtographic "vision."
