Gallery canvas is acceptable; no clip frames; no nail-hole frames; no sawtooth hangers; no photographs. All work exhibited must be for sale and will be subject to a 30% commission for non-members and 25% for TCAN members; sales tax will be collected. The submission fee is \$10.00 for one piece and \$15.00 for two. Checks should be made payable to The Center for Arts in Natick or TCAN.

JURORS: Esther Geller of Natick, Madeline Kanieff of Ashland, and Dawn Randall of Wayland-- three recognized artists from the Firehouse Studios in Natick.

End-of-Show pick up: Saturday, November 29th, from 11 to 2 PM.

\*Works not picked up on the specified dates will be subject to a storage fee of \$2 per day.
